## Purpose of job:

To manage the highway road safety engineering function to minimise road traffic accidents on the county's roads and meet our statutory duties as set out in the Road Traffic Act s39.

## Main Activities & Responsibilities:

- To oversee and manage all road safety audits stages I, II, III and IV for WCC highway improvement schemes and examine third party audits, including those for development proposals to ensure that they meet the criteria set out in HD 19/15 and all highway safety issues have been noted/addressed. Provide advice across the organisation on Road Safety Audit requirements and procedure
- To manage the road traffic accident investigation process and develop the road safety engineering
  programme and input to the maintenance programme including providing evidence for funding bids and
  evaluation reports.
- To undertake the investigation of all fatal accidents in conjunction with Police representatives and others when necessary. Make recommendations, prepare detailed reports for Asset Manager and Maintenance group. Liaise directly with Elected Members.
- To undertake research and feasibility studies into accident remedial schemes, prepare briefs, as necessary, for colleagues and consultants to undertake the detailed design and construction of such schemes.
- Provide expert guidance on all matters relating to road safety and road traffic accident reduction, including costs, effectiveness, applicability and relevant legislation.
- To establish contacts with appropriate representatives both internal and external to draw on expertise and develop working partnerships.
- To maintain and develop the established close liaison and co-operation with officers of the West Mercia constabulary in the furtherance of accident investigation, prevention and research.
- To prepare reports and evidence for public injuries and to attend such meetings as a representative of the Authority as required.
- To ensure that all surveys and other works undertaken by supervised staff are carried out within Health and Safety legislation.
- To draft technical reports for Members and Chief Officers

- To manage, coach, develop and direct the work of staff within the team, including performance, sickness, recruitment and commissioning of consultancy support
- To manage assigned budgets, including monthly forecasts, monitoring, and control
- To prepare monthly performance reports on the team's Key Performance Indicators including plans of action to address underperformance.
- To contribute to and develop strategic partnerships and groups including the Safer Roads Partnership and Midlands Service Improvement Groups for casualty reduction, traffic data and monitoring and traffic signals, National ITS groups.
